

**Subject:** FY 2016-2017 Hannibal Cox, Jr. (HCJ) Cultural Grants Program Recommendations

The FY 2016-2017 award recommendations for the Hannibal Cox, Jr. Cultural Grants Program will be computed using the established funding formula for this program. The program's FY 2016-2017 total allocation and the recommended grant award amounts per Grantee will be presented to the Council for final review later this summer, after all of the "Spring Cycle" grants program panels have convened. Final grant awards are contingent upon the availability of funds in the Department's FY 2016-2017 budget, which is subject to the County's Budget as adopted in September 2016.

## **RECOMMENDATION**

It is recommended that the Council approve the funding of 26 grants for the FY 2016-2017 Hannibal Cox, Jr. Cultural Grants Program.

## **BACKGROUND**

The Hannibal Cox Jr. Cultural Grants Program Panel, chaired by Council member Monty Trainer, convened on April 28, 2016 to review 26 applications requesting a total of \$770,000. The panel recommended funding all 26 applications.

The Hannibal Cox, Jr. Cultural Grants Program provides funding and technical assistance support to mid-sized semi-professional and professional arts, scientific and historical organizations with a full-time presence in Miami-Dade County of presenting, performing or exhibiting a year-round season of cultural activities. Grants are awarded to not-for-profit, tax-exempt organizations with annual operating budgets of \$100,000 or more. The Hannibal Cox, Jr. Cultural Grants Program is designed to assist groups in reaching their long range goals by encouraging a proposal focusing on organization development and institution building.

The panel specifically evaluated each applicant organization based on the following competitive review criteria: 1) artistic merit; 2) management capability and organizational development; 3) capacity to attract financial support; and 4) efforts leading to long-term cultural enrichment of area served.

Funding for the Hannibal Cox, Jr. Cultural Grants Program is derived from departmental proprietary revenues. All funding recommendations are contingent upon approval of the Department of Cultural Affairs' FY 2016-2017 budget by the Miami-Dade County Board of County Commissioners and Mayor, and are subject to availability of funds.

**A - 1. Ballet Flamenco la Rosa, Inc.**  
*FY 2016-2017 Season*

Funds are requested to support the 2016-2017 season of Ballet Flamenco la Rosa, a company dedicated to presenting authentic Flamenco dance with live music in theatrical settings and expand the art form beyond traditional limits and appeal to broad based audiences. This season the company will present collaborations of new works as part of their mainstage season at the Colony Theater on Miami Beach. Additionally, the company will continue to present smaller-scale performances at various venues throughout Miami Dade County and continue its series of educational and outreach performances in collaboration with various community-based organizations.

**A - 2. Florida International University Board of Trustees, for the benefit of School of Music**

Funds are requested to support the 2016-2017 concert season presented by the Florida International University (FIU) School of Music. The season program will include an eclectic array of music from all disciplines, including orchestra, jazz, contemporary, wind, band, Latin jazz, vocal, and opera. The program will highlight regional, national and international artists, as well as FIU faculty and student musicians representing all areas of Miami-Dade County. Performances will take place at the FIU Wertheim Concert Hall and other locations throughout Miami-Dade County.

**A - 3. Marjory Stoneman Douglas Biscayne Nature Center, Inc.**

Funds are requested to support the 2016-2017 season at the Marjory Stoneman Douglas Biscayne Nature Center. The center is dedicated to protecting the natural environment by providing environmental educational programs to the private and public school systems, as well as hosting various cultural arts events and programs that celebrate the environment. Events include rotating art exhibits, outdoor installations and lectures. All events will take place at the Biscayne Nature Center located on Key Biscayne.

**A - 4. Miami Beach Film Society, Inc.**

Funds are requested to support annual and ongoing programs at the Miami Beach Cinematheque. Located at Miami Beach Old City Hall, an historic building in the heart of South Beach, the Cinematheque offers weekly film screenings of foreign, art and classic films from across the globe and major film festivals such as the Sundance Film Festival, the Cannes Film Festival (among others), educational programming, art exhibitions, multi-media presentations, a world class collection of film memorabilia and special events, in an effort to promote an alternative to the commercial cinema experience.

**A - 5. Miami Dade College - Lynn and Louis Wolfson II Florida Moving Image Archives**

Funds are requested to support the 2016-2017 series of curated screenings and activities which explore the history and culture of Florida, especially South Florida, by means of its moving images, whether film or video offered at the Lynn and Louis Wolfson II Florida Moving Archives at the Miami Dade College Wolfson Campus. Since 1960, the Wolfson Archives is dedicated to preserving Florida's moving image history, sharing Florida's moving image history with educators, students, historians and individuals interested in Florida, providing filmmakers valuable visual elements for telling their stories, providing a nurturing training ground for future archivists, becoming a center for excellence and expertise in film preservation.

**A - 6. Miami Dade College - Museum of Art and Design**

Funds are requested to support the 2016-2017 series of exhibits and programs presented by the Museum of Art + Design at Miami Dade College (MDC) at the Freedom Tower in downtown Miami. The mission of the museum is to encourage the appreciation and understanding of art and its role in society through direct engagement with original works of art and art-related creative processes. Exhibitions, educational programs, student tours and engagement activities are all offered for the public's enjoyment and to encourage inquiry, while building and preserving its collection in trust for future generations. All programs are offered free of charge and open to the public.

**A - 7. Michael-Ann Russell Jewish Community Center, Inc.**

Funds are requested to support the 2016-2017 season of programs presented by the Cultural Arts Department of the Michael-Ann Russell Jewish Community Center (MARJCC). This season, the Department will present a variety of community oriented cultural arts programming designed to appeal to general audiences, including dance programs, theatre presentations, a concerts series, author presentations, film and educational lectures. Programs will take place at the MARJCC, and various locations throughout Miami-Dade County.

**A - 8. New World School of the Arts - Dance Division**

Funds are requested to support the NWSA Dance Division's Professional Choreographers' Presentation Series. National and internationally renowned professional choreographers will create and/or stage significant works of dance in collaboration with professional dancers at New World School of the Arts. Each work will be premiered for the general public as part of the New World School of the Arts' Dance Division Concert Series in the fall and and spring. Performances will take place at various locations, including the New World School of the Arts Theater, the Little Haiti Cultural Arts Center, and the Olympia Theatre at the Gusman Center for the Performing Arts in downtown Miami, the Aventura Arts and Cultural Center, among others.

**B - 1. Bas Fisher Invitational, Inc.**

Funds are requested to support the 2016-2017 season of programs presented by the Bas Fisher Invitational (BFI). Founded in 2004, BFI provides local artists and artist-initiated projects space for free expression, creativity, discourse and experimentation. This year, the Bas Fisher Invitational will continue the *Weird Miami* exhibitions, bus tours, lectures, performances, and events by a diverse range of local and national artists. A series of site-specific exhibitions and events are planned for the year at various locations throughout Miami Dade, including the Design District, Little Haiti, downtown Miami, among others. The majority of events offered by BFI are free and open to the public.

**B - 2. Creation Art Center Corporation**

Funds are requested to support the 2016-2017 season of the Creation Art Center. Founded in 1983, the Creation Art Center's mission is to preserve and encourage Hispanic culture through arts education programs for children, young adults, older adults and the elderly in the local community. This year, Creation Art Center will present original plays, musical performances, art exhibitions and other presentations featuring the talents and works of local and visiting artists and performers. All events will take place at the Miami Hispanic Cultural Arts Center, located in Little Havana.

**B - 3. Cuban Classical Ballet of Miami, Inc.**

Funds are requested to support the 2016-2017 season of Cuban Classical Ballet of Miami. Founded in 2006, the company seeks to promote the art of classical ballet and the Cuban ballet style while developing future career classical dancers. This season, performances will take place at the Miami Hispanic Cultural Arts Center in Little Havana, the Lehman Theater at Miami Dade College – North Campus and Miami Dade County Auditorium, among others. Additionally, special presentations of children's classics will be presented for students from the Miami-Dade County Public School System.

**B - 4. Diaspora Vibe Cultural Arts Incubator, Inc.**

Funds are requested to support the 2016-2017 season of Diaspora Vibe Cultural Arts Incubator (DVCAI). Founded in 1996, DVCAI seeks to promote, nurture and cultivate the vision and diverse talents of emerging artists from the Caribbean and Latin American Diaspora through exhibitions program, artists-in-residence program, international cultural exchange programs and education and outreach activities that celebrate Miami-Dade County's rich cultural and social fabric. The majority of DVCAI's activities will take place at gallery spaces along North Miami Avenue and venues throughout Miami Dade County. Funds are requested to support the 2016-2017 series of programs and activities presented by Edge Zones. The organization is committed to presenting an ambitious program of research of new works, performance and video festivals, art exhibitions, residencies and educational opportunities of more than 300 culturally diverse artists that reflect its mission to make contemporary art an integral part of the intellectual growth of the Miami community. Activities will take place at venues and exhibition spaces located in Little Haiti, Opa-Locka, and Miami Beach, among others.

Ensemble performances will take place at the Maurice Gusman Hall on the University of Miami Campus and the Coral Gables Congregational Church; other venues may be added as the season progresses.

**B - 7. Hispanic-American Lyric Theatre, Inc.**

Funds are requested to support the 2016-2017 season of the Hispanic-American Lyric Theatre. The company, formed in 1987, presents work in the field of opera, ballet and zarzuelas at venues throughout Miami-Dade County. Additionally, the company seeks to support and encourage young artists and provide them with various performance opportunities. This year, the company will perform at the Florida International University Wertheim Performing Arts Center, the Miami-Dade County Auditorium and the Steinway Piano Gallery in Coral Gables.

**B - 8. Karen Peterson and Dancers, Inc.**

Funds are requested to support the general operating costs associated with the creation and production of Karen Peterson and Dancers 2016-2017 season of dance. The company will present a year-round series of performances, including movement improvisational theater pieces, young choreographers showcase and works from the repertory performed by the Peterson and Dancers Company. The company will present a series of dance performances at the Miami Dade County Auditorium, the company's home performance venue at Excello Dance Space, as well as other venues throughout the year.

Funds are requested to support the 2016-2017 Jazz at Wolfson Visiting Artists Series (J-VAS!). Renowned jazz artists will be presented monthly at the Wolfson Auditorium, located at the downtown campus of Miami Dade College. Visiting artists will also work with students, conduct master classes and workshops. All performances are free and open to the public.

**B - 10. Miami Dade College – Koubek Center**

Funds are requested to support the 2016-2017 season presented at the Koubek Center. The Center aims to serve as Miami's multidisciplinary home for Ibero-American culture by offering classes, conferences and seminars, literary arts, visual arts and performances rooted in Ibero-American culture. For the 2016-2017 season, the Koubek Center will present the monthly music series *Little Havana Social Club, En Residencia // In Little Havana*, a residency program supporting four (4) locally-based Latino artists, and *Koubek Kids*, a monthly, bilingual family program highlighting the diverse arts, crafts, literary histories, music and dance of Miami's many Hispanic cultures. All programs will take place at the Koubek Center, located in Little Havana.

**B - 11. Miami Dade College – Teatro Prometeo**

Funds are requested to support the 2016-2017 season presented by Teatro Prometeo. This season, four (4) main stage productions will be presented - *Historia del zoologico* by Edward Albee, *Llevame a las Islas Griegas* by Cristina Rebull, *Materia oscura* by Oliver Mayer and a new commission by artist resident Emilio Rodriguez. Beginning summer 2016, Teatro Prometeo will present the sereis at the Koubek Center, located in Little Havana.

Both series feature exceptional education opportunities with the artists. Patrons of Exceptional Artists seeks to discover, promote, support and document the great Masters of the keyboard emerging in this generation, rediscover unusual repertoire, become a resource to agents, promoters and orchestras, and build the audiences of the future to help insure the very existence of classical music.

Funds are requested to support the 2016-2017 season of the South Florida Composers' Alliance (SFCA). Founded in 1985 to foster knowledge, awareness and understanding of new, experimental music, sound art and the work of living composers and sound artists, the organization seeks to act as a link between artists and their community through support in the development of new work and through opportunities for artists working in the field of sound to experiment, discuss and disseminate new ideas. This season, SFCA will present 24th Subtropics Biennial, three (3) residencies, pop-up concerts and The Listening Club. Events will take place at The Audiotheque on Lincoln Road and the Miami Beach Cinemateque.

Programs at the Cosford Cinema include first run films and documentaries, panel discussions and lectures. All programs are open to the public.
