Subject: FY 2016-17 Youth Arts Miami (YAM) Grants Program Recommendations

The FY 2016-2017 award recommendations for the Youth Arts Miami (YAM) Grants Program will be computed using the established funding formula for this program. The program's FY 2016-2017 total allocation and the recommended grant award amounts per Grantee will be presented to the Council for final review later this summer, after all of the "Spring Cycle" grants program panels have convened. Final grant awards are contingent upon the availability of funds in the Department's FY 2016-2017 budget, which is subject to the County's Budget as adopted in September 2016.

## **RECOMMENDATION**

It is recommended that the Council approve the funding of 28 grants from the FY 2016-2017 Youth Arts Miami (YAM) Grants Program.

### **BACKGROUND**

The FY 2016-2017 Youth Arts Miami (YAM) Grants Panel, chaired by Department of Cultural Affairs Deputy Director Deborah J. Margol, convened on Friday, May 6, 2016 to review 28 applications requesting a total of \$1,575,000. The Panel recommended funding all 28 applications.

The objective of the Youth Arts Miami (YAM) Grants Program is to provide operational funding support to non-profit youth arts organizations having a year-round presence in Miami-Dade County whose primary mission is to create, present or exhibit cultural programs for children and/or with children. Applicants to this program must have at least a 3-year track record of providing a year-round season of youth arts activities for children and youth. Programs must include public access components such as performances or exhibitions. Units of government and educational institutions such as schools, colleges and universities may not apply.

The YAM program is structured into three funding categories: <u>Category A</u> funds large-sized professional youth arts organizations invited to apply by Department of Cultural Affairs staff and possessing the potential to achieve regional, national or international visibility as evidenced by the organization's current programs and structure. <u>Category B</u> funds mid-sized semi-professional and professional youth arts organizations demonstrating a total prior year's organizational revenues of between \$200,000 and \$500,000. <u>Category C</u> funds small and/or developing youth arts organizations with annual organizational revenues under \$200,000.

The Panel specifically evaluated each applicant organization based on the following competitive review criteria: 1) impact - efforts to fulfill the youth arts mission of the organization; 2) artistic merit; 3) management, organizational development and financial capability; and 4) reach (ability to reach underserved children and youth who may be limited by geography, economics or disability and impact on and involvement of Miami-Dade's multicultural community). Attached is a list describing the organizations and programs recommended for funding.

Funding for the Youth Arts Miami Grants Program is derived from departmental proprietary revenues. All funding recommendations are contingent upon approval of the Department of Cultural Affairs' FY 2016-2017 budget by the Miami-Dade County Board of County Commissioners and Mayor, and are subject to the availability of funds.

### Grant #: 1 - All Florida Youth Orchestra, Inc. dba Florida Youth Orchestra

**Award:** Grant Amount to be calculated based on YAM funding formula

Grant funds will be used to support music education and outreach performances for 3,500 youth ages 5-18, at public schools, mainstage concerts and community sites in a variety of cities/neighborhoods in Miami-Dade County. Activities include orchestral training, violin instruction for at-risk youth, Family Concerts for young children, and outreach performances. Participants will engage in music education and benefit from improved: musical ability, social/behavioral skills and self-esteem.

**Award:** Grant Amount to be calculated based on YAM funding formula

Grant funds will be used to support The Youth Drum Line (YDL) and the Teens Acting & Drama Studio (TADS) programs for 65 students ages 7-18, at the Betty T. Ferguson Recreational Complex in Miami Gardens. YDL activities will include percussion classes, performances, music theory, sight-reading, music composition and applied skills; TADS activities include acting, student performances, voice and diction and stage craft skill development. Participants will engage in musical and theater arts, while benefitting from learning new arts skills.

### Grant #: 3 - American Children's Orchestras for Peace, Inc.

Grant funds will be used to support ACOP's musical programs impacting 2,375 students ages 6-18, at schools andparks located within the most economically challenged areas of Miami-Dade County, including Little Haiti, Overtown, and Little Havana. Activities include year-round after school music programs and performances throughout Miami-Dade's multi-ethnic communities. Participants will engage in music lessons and benefit from learning instrumental technique, music theory, and music history.

Grant funds will support the Area Stage Company's (ASC) Conservatory Program for 1,000 students ages 6-22, at the Area Stage Company in Coral Gables and at area schools for children with developmental disabilities. Activities include workshops in theater, musical theatre, orchestra and technical theatre, and participation in ASC's professional conservatory productions. 10,000 additional students will participate by attending free dress rehearsals and field trip performances.

Grant funds will be used to support Ballet Etudes' outreach and performance season for 150 students ages 10-17 at various venues across Miami-€' Dade County in the communities of Hialeah, Miami Lakes, and Miami Beach. Program activities will include ballet training and performances. Participants will engage in ballet training and benefit from artistic and personal development.

Grant funds will be used to support Diva Arts' overall programs for 175 students ages 5-19, at Diva Arts Dance Studio in the City of Miami Gardens. Program activities will include a multi-disciplinary performing arts curriculum that provides training in ballet, modern, contemporary, tap, hip-hop, acrobatics and choreography to underserved youth, in order to educate, empower and enrich the participating children and youth.

Grant funds will be used to support a year round arts program for 600 students ages 11-18 at enFAMILIA in Homestead and Florida City. Activities include multidisciplinary arts classes, exhibits and performances where students engage in dance, music, drama, creative writing, film production, and visual arts. Students will benefit from learning various arts skills, as well as the causes, consequences and solutions to substance abuse and at risk behaviors.

Program activities will include touring theatre shows and workshops. Participants will engage in theatre arts and benefit from exposure to educational, culturally enriching theatre performances and interactive workshop experiences.

Program activities will include all aspects of filmmaking as an art and career path. Participants will engage in script writing, acting and directing and benefit from literacy and working together as a team to produce a short film.

Program activities will include rehearsals, concerts, workshops, and family sing-alongs. Participants will explore standard and experimental forms of choral music and benefit by developing musicianship, vocal technique, disciplined effort and sustained commitment.

Program activities will include theater classes, productions and summer camps. Participants will engage in performing arts disciplines such as singing, acting and dancing and will benefit from being part of a team that works together to create a full-scale production.

Musical Theater Camps and InSchool Workshops for students plus OnCall sessions for hospitalized children/youth will stimulate educational and social development progress.

Participants will engage in voice/movement training, social skills building and on-stage performances, and benefit from artistic-performance training.

Participants engage in ballet, tap, modern and alternate dance genres. Literacy and math will also be provided at the four satellite locations. Students will achieve mastery of dance skills and learn discipline, consistency, focus and the delay of gratification. Math and reading scores will improve!
