Subject: FY 2015-2016 Designated Major Cultural Institutions Grants Program
Recommendations – Interim Review

The FY 2015-2016 award recommendations for the Major Cultural Institutions Grants Program will be computed using the established funding formula for this program. The program's FY 2015-2016 total allocation and the recommended grant award amounts per Grantee will be presented to the Council for final review later this summer, after all of the "Spring Cycle" grants program panels have convened. Final grant awards are contingent upon the availability of funds in the Department's FY 2015-2016 budget, which is subject to the County's Budget as adopted in September 2015.

RECOMMENDATION

It is recommended that the Council approve the funding of fourteen (14) grants for the FY 2015-2016 Major Cultural Institutions Program.

BACKGROUND

The Major Cultural Institutions Program Panel convened on Thursday, May 21, 2015 to review thirteen (13) applications to the Major Cultural Institutions Grants Program. The Panel recommended funding all thirteen (13) applications. It is further recommended that the Council appropriate funding from the FY 2015-2016 Major Cultural Institutions program allocation to facilitate the transition of Gablestage, Inc. into the Coconut Grove Playhouse as its theater presenter and operator, and for programming support.

As part of the County's Proposed FY 2015-2016 Budget, four previously designated Major Cultural Institutions grant recipients, HistoryMiami, Perez Art Museum Miami, Patricia and Phillip Frost Museum of Science, and Vizcaya Museum and Gardens, have been recommended for County funding outside of the Department's grants budget as direct allocations through Convention Development Tax revenues. Grants for each of these four institutions, therefore, which take into account their past Major Cultural Institutions program funding award levels, are not part of the program this year, nor within the purview of the Council to review and recommend. Further, three of the FY 2015-2016 designated Major Cultural Institutions grant recipients, Fairchild Tropical Botanic Garden, Inc., The Miami Children's Museum, Inc., and the Zoological Society of Florida, Inc. for ZooMiami, have been recommended as direct allocations through the Department, but independent of the Major Cultural Institutions competitive process. Convention Development Tax revenues sufficient to support these direct allocations are being included in the Mayor's Proposed FY 2015-2016 Budget as part of the Department's grants budget for this specific purpose. Grants for each of these three institutions, therefore, which take into account their past Major Cultural Institutions funding award levels, are not part of the competitive program this year, nor within the purview of the Council to review and recommend.

The Major Cultural Institutions program is designed to provide stable and substantial funding to fully professional institutions with year-round programs and annual fiscal operations in Miami-Dade County specifically that satisfy the eligibility requirements. The objective of this program is to help support the annual operations of and programming provided to the community by Miami-Dade's largest, exemplary

cultural organizations. In so doing, the program assures the steady provision of outstanding cultural products throughout Miami-Dade County and contributes to the overall vitality of Miami-Dade County as a community and as an attractive tourist destination.

The Major Cultural Institutions Grants Program operates on a four-year review cycle. A comprehensive application and review process was conducted for FY 2014-2015. Scores achieved and grants awarded during the FY 2014-2015 cycle define the grant award levels from FY 2014-2015 to 2017-2018, with the interim funding cycles subject to possible annual adjustments based on audited and updated organizational budget information, and contingent upon the availability of funding and upon fulfillment of interim year application/reporting requirements provided by the grantee and accepted as satisfactory by the Department of Cultural Affairs. FY 2015-2016 represents the second year of the current four-year funding cycle for this program. Staff has thoroughly reviewed all interim applications, support materials and financial reporting documentation submitted from current applicants.

The program operates with two categories of eligibility for designation as a Major Cultural Institution: Category A / performing arts institutions; and Category B / museums and visual arts institutions. For the comprehensive FY 2014-2015 cycle, the Panel determined that each designated institution: provides a sustained level of cultural and program excellence that is generally recognized throughout the community and within its artistic discipline nationally; makes significant, continuing contributions to the artistic, cultural and economic life of Miami-Dade County; has a proven track record of presenting full and regular seasons of changing cultural programs and/or exhibitions open to the general public for an uninterrupted five year period; documents trends of major Miami-Dade audience support through annual subscriptions and/or memberships, earned income and fund raising for each of the preceding three years; substantiates a three-year average operating revenue budget specific to Miami-Dade County activities in excess of \$3 million for performing arts institutions, and similarly, in excess of \$1.5 million for museums and visual arts institutions, exclusive of tangible collections, capital funds or assets, and/or endowment corpus; offers a professionally managed education program that benefits all segments of the community; and demonstrates long term fiscal responsibility and long range planning, among other defining, threshold requirements. The Panel specifically evaluated and ranked each applicant organization in FY 2014-2015 based on the following competitive review criteria: 1) cultural excellence; 2) organizational stability and management capacity; 3) impact and audience development; and 4) outreach programs.

The FY 2015-2016 Panel recommended continued designation of the Miami Symphony Orchestra and M Ensemble Company as "emerging" Major Cultural Institutions. Each of these two organizations continues to demonstrate the potential to have an impact in the quality and reach of their programs which is commensurate with this designation. The Miami Symphony Orchestra is one of the few Hispanic-identified orchestras in the country representing and serving a major metropolitan area. M Ensemble Company is the oldest African American professional theater company in the state. Targeting significant support to each of these organizations enables each to continue to strengthen its organizational growth and stability through enhanced administrative and fiscal capacity. These organizations are especially well poised to develop into Miami-Dade County's first Hispanic and African American major cultural institutions. To further augment these organizations' development, it is recommended that each continues to be provided funding from technical assistance funds to cover the costs of advanced technical assistance services during FY 2015-2016. Each emerging Major Cultural Institution will work in direct consultation with Department staff to determine a critical, organizational capacity building initiative for which this technical assistance support may be accessed and utilized.

All eligible institutions are legally incorporated as non-profit organizations and designated tax-exempt by the United States Internal Revenue Service. Funding recommendations are in support of each institution's Miami-Dade County activities only. Attached is a list describing the institutions recommended for funding. Funding for the Major Cultural Institutions program is derived from Departmental proprietary revenues. All funding recommendations are contingent upon approval of the Department of Cultural Affairs' FY 2015-2016 budget by the Miami-Dade County Mayor and Board of County Commissioners, and are subject to the availability of funds.

1	<p>Award amount to be calculated based on MCI funding formula</p> <p>Actors' Playhouse Productions, Inc. - The mission of Actors' Playhouse is to enrich the cultural vitality of South Florida with the highest caliber classic and contemporary live theater productions; to provide comprehensive education and outreach programs to multicultural and multigenerational audiences; to provide a supportive and creative work environment for Florida-based theater professionals; to encourage the creation and production of new works for adults and children; and to maintain the cultural identity of its home venue, the historic Art Deco Miracle Theatre in Coral Gables.</p>
2	<p>Award amount to be calculated based on MCI funding formula</p> <p>Florida Grand Opera, Inc. – The mission of Florida Grand Opera (FGO) is to produce opera and musical programs in South Florida for the benefit of residents and visitors, and to educate and increase audiences for the art form through outreach programs with a special emphasis on programs for young people. FGO's Young Artist Program, founded in 1984, is recognized <u>worldwide</u> as one of the leading and most highly competitive operatic training programs in the US, accepts only 6-10 artists from over 600 applicants each year and to date, has trained more than 160 young professionals who now appear on the stages of the nation's leading operatic and theatrical organizations.</p>
3	<p>Award amount to be calculated based on MCI funding formula</p> <p>Florida International University Board of Trustees, for the benefit of Jewish Museum of Florida - The mission of the Jewish Museum of Florida-FIU (JMOF) is to collect, preserve and interpret the material evidence of the Florida Jewish experience from 1763 to the present. Housed in an Art Deco building that was formerly an historic synagogue, the elements of the Museum include the Collections and Research Center, a core exhibition of Florida Jewish history, temporary exhibits, films, interactive computer stations, a timeline of Florida, American and World Jewish history and public educational programs.</p>
4	<p>Award amount to be calculated based on MCI funding formula</p> <p>Florida International University Board of Trustees, for the benefit of –The Patricia and Phillip Frost Art Museum - The Frost Art Museum at FIU's mission is to enrich and educate local, national and international audiences through the language of art by collecting, preserving, researching, interpreting and exhibiting art from diverse cultures throughout human history. The Museum, a dynamic cultural resource with a particular emphasis on Latin American and 20th century American art, is located on the FIU campus and serves as an exceptional resource for scholarly research and interdisciplinary collaboration and presents free and accessible programs to the broadest possible audiences in Miami-Dade County.</p>
5	<p>Award amount to be calculated based on MCI funding formula</p> <p>Florida International University Board of Trustees, for the benefit of The Wolfsonian - The Wolfsonian's mission is to support the collection, preservation, research, exhibition and publication of material arts from 1885 to 1945. The Wolfsonian oversees a collection of over 90,000 North American and European artifacts, including furniture, glass, ceramic, metalwork, books, paintings and sculpture, as well as extensive period archives. The Wolfsonian promotes scholarship in decorative arts history, design and architecture by examining the meaning of objects and the effect that material agents of change had on the development of the modern world.</p>

6	Award amount to be calculated based on MCI funding formula	<p>Friends of the Bass Museum, Inc., for the Bass Museum of Art – The Museum’s mission is to collect, preserve, exhibit and interpret the visual arts for the residents and visitors of the City, the County and the region, as well as an international community of scholars. The Museum achieves its mission by developing exhibitions from its permanent collection and presenting loaned exhibitions from national and international collections, stimulating tourism and providing an important cultural destination for the City. MISO strives to enlighten, entertain and educate Miami-Dade’s multicultural community. MISO is one of only a few minority-operated symphony orchestra’s in the United States.</p>

13	Award amount to be calculated based on MCI funding formula	University of Miami, Lowe Art Museum – The Museum’s mission is to serve the University, the Greater Miami communities, and national and international visitors as a teaching and exhibiting resource through its permanent and borrowed collections. The Museum: collects original, quality works of art primarily from Asia, Africa, Europe and the Americas; exhibits and preserves the permanent collection according to the highest professional standards; researches the permanent collection and publishes the findings in exhibition catalogues and articles; and organizes traveling exhibitions and loans of individual works from the permanent collection.

14	Award amount to be calculated based on MCI funding formula	Gablestage, Inc. / Coconut Grove Playhouse – It is anticipated that Major Cultural Institutions grant funding in FY 2015-16 would be used to facilitate Gablestage’s transition into the Coconut Grove Playhouse as its theater presenter and operator. The funds will be used to address Gablestage’s strategic organizational capacity building, to support programming that benefits the Coconut Grove community and the community at large, and to re-establish the Coconut Grove Playhouse as a venue that produces professional regional theater.

The Museum is recognized for initiating and maintaining a broad array of partnerships with community and professional organizations for delivering its educational/outreach programs to a diverse audience.

N/A	Zoological Society of Florida, Inc. for Zoo Miami - The mission of the Society is to encourage an appreciation for the world’s wildlife and to help conserve it for future generations. Zoo Miami, a living museum accredited by the Association of Zoos and Aquariums, is the oldest and largest zoo in Florida, and the only tropical zoo in the US. With over 740 available acres, Zoo Miami is five times larger than the average U.S. zoo and was one of the first cageless zoos in America.
