# Festivals and Special Events (FEST) Grants Program

The Festivals and Special Events Grants Program (Comprehensive Year) Panel, chaired by Deborah Margol, convened on June 23, 2015 to review 16 applications requesting a total of \$1,230,000. The Panel recommended funding all 16 applications.

Of the sixteen (16) grants, one (1) organization, Miami Hispanic Ballet Corp., had not submitted an application during the comprehensive grant cycle in FY 2014-2015 and was therefore, evaluated on a comprehensive basis during this panel evaluation and is being recommended for funding contingent upon available funds during this fiscal year. One (1) previously designated and funded organization through this grants program, Festival Miami presented by the University of Miami Frost School of Music, did not submit a complete application for the 2015- 2016 cycle. Staff is working with this organization to explore other grant opportunities available through the Department for which they might qualify.

The program's final grant awards are contingent upon the availability of funds in the Department's FY 2015-2016 budget, which is subject to the County's FY 2015-2016 Budget once adopted in September 2015.

# Youth Arts Enrichment (YEP) Grants Program

The Department of Cultural Affairs FY 2015-2016 Youth Arts Enrichment Program (YEP) Panel convened on July 9, 2015 to review 40 applications requesting a total of \$583,120.00. # Miami-Dade County Budget: FY 2015-2016 Grants Recommendations for Annual Programs

Ms. Margol reported that Miami Contemporary Dance Company has gone out of business. The \$45,000 allocated to them through the Cultural Advancement Grants Program - Category B is recommended to be redirected to Culture Shock Miami.

All other grant allocations will remain the same as FY 2014-2015.

Mr. Spring noted that second budget hearing will begin on September 16 at 5:01 PM. He also noted that there was no discussion about the Department's budget at the first budget hearing.

He reported that the budget to operate the 7th Avenue – Carver Theater is expected to be resolved at the second budget hearing. Negotiations with Fantasy Theater Factory and M Ensemble are underway. With a proposed budget of approximately \$400,000, Fantasy Theater Factory will manage operations of the theater and M Ensemble will be the resident theater company.

Ms. Chancy-Gonzalez inquired about funds to repair or restore artwork. Mr. Spring noted that the funds are part of the Art in Public Places budget.

Mr. Pérez asked how many pieces are in the collection. Mr. Spring reported that there are currently more than 700 pieces.

Ms. Ibargüen asked why there was a direct allocation of \$1.3 million for certain organizations. Mr. Spring noted that the Board of County Commissioners removed them from the competitive process in favor of direct allocations.

Ms. Ibargüen inquired as to whether or not there is an issue with the County funding the John Paul II Film Festival. Ms. Barba noted that because of the nature of the organization, the application went through a very thorough review to determine that there would not be a issue.

Mr. Bierman asked if the grant program encouraged local filmmakers. Mr. Spring noted that while the Department does not currently have a grants program dedicated to local film production, a number of the grants programs support the activities of independent filmmakers, including the South Florida Cultural Consortium's Visual and Media Artists Fellowship Program.

#### REPORTS AND DISCUSSION ITEMS

### Culture Shock Miami - Discount Tickets for Youth Program

Ms. Beauvoir reported that Culture Shock Miami prepares to wrap up its current season with more than 460 events made available to its target audience since the beginning of the 2014-2015 fiscal year. To date, 9,879 tickets have been sold for the current 2014-2015 cultural season. In addition, 2,005 students have been reached through free outreach performances and workshops in collaboration with the Miami-Dade Public School System and the South Miami-Dade Cultural Arts Center, bringing the program's total reach to date to 11,884. This represents an increase of 14.47% from the 2013-2014 cultural season.

Ms. Beauvoir introduced Katherine Robertson who is working with the program as an intern. She will be working with outreach and social media. She will also serve as the liaison for the student council.

#### **Department Facilities Update**

### South Miami-Dade Cultural Arts Center (SMDCAC)

Mr. Fliss reported that Thomas Armour Youth Ballet ended a very successful summer camp in August. The Center also hosted Miami Lyric Opera's production of *Rigoletto* and a camp for Guitars over Guns.

The Center produced *Tsunami* by Nilo Cruz which ran for 13 performances. Reviews of the show were excellent.

SMDCAC will be presenting a film series, Indie Flicks. Screenings are funded in part by a grant from South Arts in partnership with the National Endowment of the Arts.

In partnership with Thomas Armour Youth Ballet, the Center will be hosting regular dance classes, three days a week. Students who qualify for the reduced lunch program at school or are low income will receive reduced rates.

### Joseph Caleb Auditorium

Ms. Valles reported that the Joseph Caleb Auditorium received the 2015 Achievement Award from the National Association of Counties (NACo) for its program titled "Caleb Cultural Passport Program." The award received was for Best of Category in Arts and Historic Preservation, which honors innovative programs that enhance services for the residents.

Ms. Valles noted that construction on the garage has been delayed. Within the next week, construction will begin on the tower structure.

To date, the Auditorium has had an attendance of 36,288 for FY 2014-2015.

#### 7th Avenue - Carver Theater

Mr. Spring reported that an operating agreement between Fantasy Theater Factory and M Ensemble is being drafted. Fantasy Theater Factory will handle all operational needs and M Ensemble will serve as the resident theater company.

#### Art in Public Places Update

Ms. Reddick reported that Fringe Projects, temporary art installations throughout downtown as part of DWNTWN Arts Days, took place September 11 - 13. Among the featured artists were Dara Friedman, David Brooks and Nate Page.

In collaboration with Miami-Dade Parks, Recreation and Open Spaces and the Friends of the Underline, Art in Public Places (APP) received a \$200,000 grant from ArtPlace America to implement a series of temporary art projects for a 10-mile park underneath the Metrorail. The consulting artist team of Bhakti Baxter, Nicolas Lobo, Naomi Fisher and Augustina Woodgate will collaborate to create works that vary in duration.

In collaboration with the University of Miami School of Communications, APP received a \$60,000 grant from the Knight Foundation to implement a series of temporary public art installations that will examine the impact of sea level rise on Miami-Dade County. A Call to Artists has been issued and will close on September 30, 2015.

APP is working with the City of Miami Beach to implement the public art requirements for the renovation and expansion of the City of Miami Beach Convention Center, a \$4.3 million project. Nineteen international artists will present proposals beginning September 28, 2015.

Ms. Reddick reported that APP has been approached by the Downtown Development Authority to administer the Downtown Baywalk Project. The proposed project will link downtown Miami's waterfront properties by creating a publicly accessible walkway along Biscayne Bay.

Mr. Aguirre inquired about the selection process for the City of Miami Beach Convention Center. Mr. Spring noted that a panel from the the City of Miami Beach Art in Public Places program has been appointed to review the proposals. He has been chosen to chair the deliberations. Ultimately, the finalists chosen by the panel will go before the City of Miami Beach Commission for approval.

### **DIRECTOR'S REPORTS**

- Mr. Spring introduced new employee Olga Gonzalez who is working with Ms. Lee on the accounting needs of the department.
- He noted that the Department's facilities received more "Top Picks" in *The Miami Herald* Season Preview section than any other facility.
- Ms. Ibargüen expressed concern that there was a general lack of awareness about the work of the Cultural Affairs Council. Mr. Spring noted that all money is directed toward transactional activities, selling tickets as opposed to brand awareness. Mr. Henriques observed that there is high recognition and appreciation within the arts community of the Council's and Department's work.
- Mr. Spring noted that the Department has a set of talking points which will redistributed to Councilors at the next meeting.
- Mr. Aguirre inquired about orientation on the Department's work for new officials. Mr. Spring reported that there is a very thorough orientation for new County officials.
- Mr. Spring reported that the Department will be hosting a summit celebrating the silver anniversary of the American with Disabilities Act. The event will be held at the Arsht Center September 24-25 and will feature national experts.
- Mr. Spring reported that the research and analysis phase for the Coconut Grove Playhouse is underway.

#### **COUNCILOR REPORTS**

- Mr. Trainer reported that New Word School of the Arts students continue to receive awards including BFA graduate Rafael Domenech who received the Tulsa Artist Fellowship.
- Ms. Sigars-Malina reported that the Bromeliad Society of South Florida will be holding a rare plant auction in October at Fairchild Tropical Botanic Garden. She also noted that Fairchild has a new website.
- Mr. Jensen reported that the Redland Farm Life School will be celebrating its 100th anniversary in 2016. He also reported that the Seminole Theatre will open in November.

With no further business, the meeting was adjourned at 1:50 PM.
