If full appropriation is funded, all 478 will be awarded their qualified grant amounts OR all 478 grant amounts will be reduced by a score-based formula that proportionally distributes the final appropriation.

matching grants for specific cultural projects request **\$ 2,980,028**

These grants are funded at full request by ranking until the final appropriation is depleted.

matching grants for capital projects request **\$12,499,777**

These grants are funded by ranking until the final appropriation is depleted.

17 recommended

CULTURAL ENDOWMENTS

for state matching shares request **\$ 4,080,000**

These state matches are funded by ranking until the final appropriation is depleted.

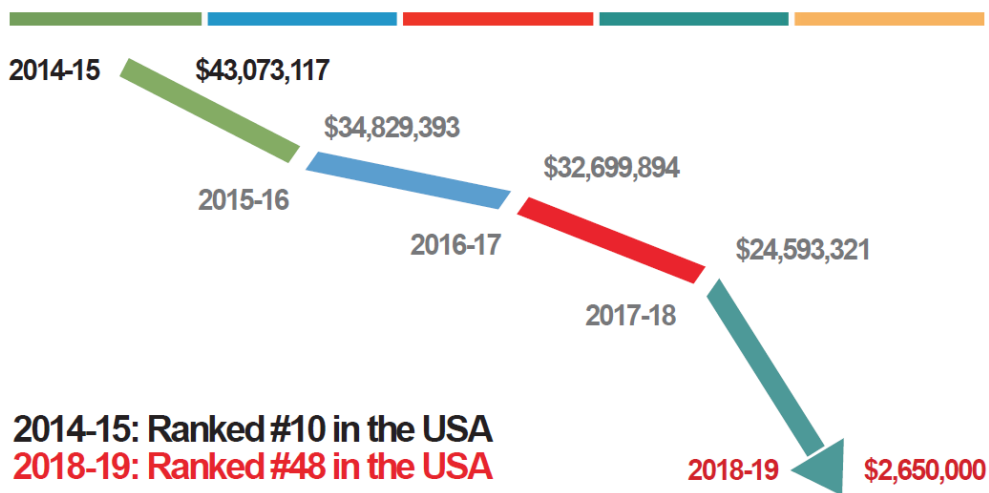
